

WHEREAS:

- 2. UBL FUND MANAGERS and the Trustee have agreed to further amend the Deed as authorized under Clause 20.2 of the Deed so as to make some amendments.
- The Securities & Exchange Commission of Pakistan ("SECP") vide its letter No. SCD/AMCW/AIAIF/44/2014 dated July 25, 2014 has approved the amendments to the Deed.

Amendments to the Trust Deed:

1. Cover Page

The Title of the Fund is amended and read as follows: "Al-Ameen Islamic Aggressive Income Fund (AIAIF)"

2. Amendment in Clause 1:

The Fund will now be constituted as Al-Ameen Islamic Aggressive Income Fund (AIAIF)

- In the Trust Deed any reference to Al-Ameen Islamic Income Fund (AIIF) shall be replaced with Al-Ameen Islamic Aggressive Income Fund (AIAIF).
- 4. All other contents of the Trust Deed remain unchanged and the Trust Deed shall continue to remain in full force and effect, amended as above.

For the purpose of stamp duty this deed valued at Rs. 5000/- and the prescribed stamp duty of sum of Rs. 1000/- affixed accordingly.
